# PRESIDENTS REPORT

It has been a busy and challenging year and a lot has happened since my first annual report twelve months ago.

It seems a long time since the outbreak of Covid-19, the shutdown of racing and the emergency support package Winston Peters and the coalition Government provided to help the TAB which was on the verge of insolvency. The Covid-19 situation has changed the way business is conducted around the world and our industry has had to adapt to this. However, as we have seen many times over the years the Thoroughbred Industry has the ability to bounce back from adversity and we now need to improve outcomes for stakeholders.

The coalition Government has delivered on its promise to create a framework that will enable the industry to take the reins and move itself forward as a more cohesive unit. The NZTBA staff and council members have been doing their best to assist with this by providing representation for the breeding industry in many different areas. The NZTBA have contributed a great deal during the year on issues such as education, animal welfare, Healthy Rivers Waikato, Covid 19 protocols, Racing Bill submissions and animal health just to name a few.

I'm sure you will all agree Justine Sclater our CEO and Corrina Holmes our Financial Officer have done a great job with their communication and information sharing to keep you up to date and help make informed decisions. I would like to thank Justine, Corrina and all our council members on behalf of the industry for their support and efforts.

At last year's NZTBA AGM a proposal was approved by our members to reduce the council from 11 members to 8. This constitutional change will come into effect after this year's AGM. Our council will now consist of three (3) regional members to be nominated and voted on by the members of each particular region and five (5) National members to be nominated and voted on by all members. Going forward this will enable us to have a more diverse range of skills at our council table.

As a result of these changes we will be having an election for the first time in 20 years for our Northern Region representative. I would like to thank the three retiring councillors Gus Wigley, Chris Dennis and Rochelle Kerr for their contributions over the years and wish them all the best. Our final council line up will be announced at the AGM.

Detailed financial information and other office activities can be found further on in this report. Our office is to be commended for doing such a great job with the NZTBA's finances. A net surplus after taxation of \$63,452 is a great result for our association.

A lot of effort goes in to organising these events and let's hope we can put 2020 behind us and enjoy catching up next year.

The Association has two beautiful commissioned sculptures by Cambridge sculpture Nicola Lewis for our coveted Sir Patrick and Justine Lady Hogan Breeder of the Year and our Eight Carat Broodmare of the Year awards. We are proud that these will be a legacy for our most prestigious breeding awards for years to come. Joan also restored the Personality of the Year Trophy to its former glory and it is a truly magnificent trophy.

Thank you also Waikato Stud for their generous donation of a service to their champion stallion Ocean Park to the Waikato Branch of the NZTBA. The Waikato Branch run many events for all members to attend and Waikato Stud's generosity is appreciated by all of us.

Our Irish National Stud scholarships continued amid the Covid pandemic and I commend both Hannah Airey and Laura McNab for their maturity and ability to cope in spite of the difficulties they faced. Both graduated with Certificates of Distinction, with Hannah achieving top marks in the Veterinary exam. # INDEPENDENT AUDITOR'S REPORT



TO THE MEMBERS OF NEW ZEALAND THOROUGHBRED BREEDERS ASSOCIATION INC.

## OPINION

We have audited the special purpose financial statements of New Zealand Thoroughbred Breeders Association Inc., which comprise the balance sheet as at March 31, 2020 and the statement of profit or loss for the year then ended, and notes to the special purpose financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying special purpose financial statements of the New Zealand Thoroughbred Breeders Association Inc. for the year ended March 31, 2020 are prepared, in all material respects, in accordance with accounting policies described in Note 1 to the special purpose financial statements.

## BASIS FOR OPINION

We conducted our audit in accordance with International Standards on Auditing (New Zealand) (ISAs (NZ)). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Special Purpose Financial Statements section of our report. We are independent of the entity in accordance with Professional and Ethical Standard 1 (Revised) Code of Ethics for Assurance Practitioners issued by the New Zealand Auditing and Assurance Standards Board, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Other than in our capacity as auditor we have no relationship with, or interests in, the New Zealand Thoroughbred Breeders Association Inc.

## EMPHASIS OF MATTER – BASIS OF ACCOUNTING AND RESTRICTION ON DISTRIBUTION

We draw attention to Note 1.1 to the special purpose financial statements, which describe the basis of accounting. The special purpose financial statements are prepared to assist the members of the entity in complying with the special purpose framework referred to above. As a result, the special purpose financial statements may not be suitable for another purpose. Our report is intended solely for the members of the entity and IRD and should not be distributed to other parties. Our opinion is not modified in respect of this matter.

## EMPHASIS OF MATTER – COVID-19

Without modifying our opinion, we draw attention to the disclosure in note 11 on page 14 which outline the possible effects of the Alert Level 4 lockdown as a result of the Covid-19 pandemic.

## OTHER MATTER

The special purpose financial statements of New Zealand Thoroughbred Breeders Association Inc. for the year ended 31 March 2019 were audited by another auditor who expressed an unmodified opinion on 12 August 2019.

## OTHER INFORMATION

The Executive Committee are responsible for the other information. The other information comprises Association information included in the Association's report, but does not include the financial statements and our auditor's report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of audit opinion or assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

## EXECUTIVE COMMITTEE' RESPONSIBILITIES FOR THE SPECIAL PURPOSE FINANCIAL STATEMENTS

The executive committee is responsible for the preparation of the special purpose financial statements in accordance with the special purpose framework and for such internal control as those charged with governance determine is necessary to enable the preparation of special purpose financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the special purpose financial statements, those charged with governance are responsible for assessing the entity's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless shareholders either intend to liquidate the entity or to cease operations, or have no realistic alternative but to do so.

Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these financial statements.

As part of an audit in accordance with ISAs (NZ), we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the special purpose financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.





# NOTES TO THE FINANCIAL STATEMENTS NEW ZEALAND THOROUGHBRED BREEDERS ASSOCIATION (INC.) FOR THE YEAR ENDED 31 MARCH 2020

## NOTE 1: STATEMENT OF ACCOUNTING POLICIES

### 1.1 Statement of Accounting Policies

The entity reporting is New Zealand Thoroughbred Breeders' Association (Inc.) (NZTBA), which is registered under the Incorporated Societies Act (1908). The accounts have been prepared in accordance with the Special Purpose Framework for use by For-Profit Entities (SPFR for FPEs) published by the New Zealand Institute of Chartered Accountants.

The Financial Statements have been specifically prepared for the members and for the Inland Revenue Department.

### 1.2 General Accounting Policies

The measurement base adopted is that of historical cost.

### 1.3 Particular Accounting Policies

#### Accounts Receivable

Accounts receivable are stated at expected realisable value. Provision has been made for bad debts where considered necessary.

#### Fixed Assets and Depreciation

Fixed Assets are recorded at cost and with the exception of the Library, have been depreciated at maximum rates allowable by the Inland Revenue Department for taxation purposes. These rates are considered appropriate for the purposes of these

financial statements. The Library contains stud books, stallion registers and reference books which has historical interest and have not therefore been depreciated. Depreciation rates used are shown below:

Fixtures & Fittings	2% - 25% DV
Office Equipment	20% - 60% DV

#### Income Tax

The Association adopts the taxes payable method of accounting for income tax.

Income and expenditure directly attributable to the membership of the Association is non-assessable for taxation purposes.

Income tax benefits arising from income tax losses are only recognised where there is virtual certainty of their realisation.

#### Subscription Revenue

The subscription year runs from 1 April to 31 March. Income from subscriptions is taken up on an accrual basis.

#### GST

GST is accounted for on a payment basis. Revenue and expenses are shown net of GST.

### 1.4 Changes in Accounting Policies

There have been no changes in the above accounting policies which have been applied on bases consistent with those in previous years, with the exception of subscriptions that were reported on a cash received basis.

**NOTE 3: FAMIS TERM DEPOSIT**

The Association's FAMIS incentive scheme was started in 1992 and finished on 31 July 2006. The residual Bonus pool held at that date was \$107,525. In 2006 the Council resolved that the residual pool be retained and applied to future racing/breeding projects. In March 2013, the Council resolved to transfer \$7,525 from this fund to the new Pearl Series Bonus Scheme to assist the launch and promotion of the Series. In March 2014 the Council resolved to transfer \$10,000 from this fund to assist the Association with the moving costs associated with the abandonment of the NZTBA office at Ellerslie Racecourse. At balance date the residual fund is now \$90,000. This is secured by a corresponding amount on Term Deposit at the Bank of New Zealand, Matamata Branch. The FAMIS fund balance is not reflected in the Association's Statement of Financial Position as it has been transferred to Equity.

**NOTE 5: PURPOSE OF OPERATIONS**

The Association operates in New Zealand within the breeding sector of the thoroughbred racing industry.

**NOTE 6: NEW ZEALAND THOROUGHBRED MARKETING LIMITED**

In 1998 New Zealand Thoroughbred Marketing Limited (NZTM) was established to take over the marketing function previously undertaken by the Association.

NZTM is three fifths owned by the Association, with the other shareholders being NZ Bloodstock Limited and NZ Thoroughbred Racing (formerly NZ Racing Conference).

The investment in this company is not paid up and represents a contingent liability to the Association of \$2 as at 31 March 2020. (2019: \$2)

## NOTES TO THE FINANCIAL STATEMENTS NEW ZEALAND THOROUGHBRED BREEDERS ASSOCIATION (INC.) FOR THE YEAR ENDED 31 MARCH 2020 (CONTINUED)

Legal entitlement to the New Zealand Bloodstock Limited 0.50 percent levy from the sale of thoroughbreds in NZ is held by the Association. The Council has agreed however to pass this revenue on to NZTM to be used for marketing purposes by that company.

At year end any amounts receivable from NZ Bloodstock Limited are in turn due to NZTM under the above arrangement. They therefore have no impact on the results of the Association and have not been recognised in the Statement of Financial Position.

### NOTE 7: CONTINGENCIES

As stated in Note 6 above, the Association has a contingent liability for its unpaid capital investment in NZ Thoroughbred Marketing Limited of \$2, There are no other contingent liabilities at 31 March 2020 (2019: \$Nil).

### NOTE 8: COMMITMENTS

#### CAPITAL

The Association has no capital commitments as at 31 March 2020 (2019: \$NIL).

### NOTE 9: RELATED PARTIES

The Association is involved in a joint venture with Professional Printing and Systems Ltd which is part-owned by the family of Past President, the late Peter Francis. The joint venture produces and publishes the annual Register of Thoroughbred Stallions of New Zealand. For the year ended 31 March 2020, the value of the profit share received from the joint venture was \$19,942 and the value of the goods and services purchased from the entity was \$15,284.

### NOTE 10: LEASE COMMITMENT

The Association has entered into a three-year lease on premises at 9 Anzac Ave, Cambridge at an annual rental of \$18,375, with two rights of renewal for further terms of three years each. The commitments for minimum lease payments are payable as follows:

However, economic uncertainties have arisen which are likely to negatively affect the operations and services of the Association. We describe below the possible effects on the Association that we have identified, resulting from the Covid-19 pandemic:

- A decline in membership with a decline in members breeding thoroughbreds.
- A reduction in sponsorship.

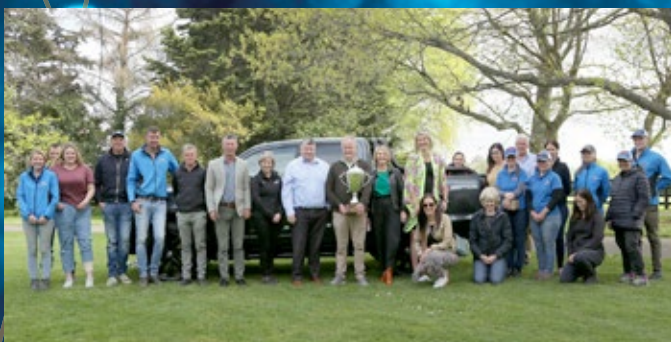

## HONOURING EXCELLENCE WITH OUR NATIONAL BREEDING AWARDS

Out of adversity comes creativity and that has certainly been the case with the NZTBA's new Ebbett VW NZTBA National Breeding Awards.

This year was the first year of hosting such awards in conjunction with the Waikato Branch, sponsors were organised, new trophies commissioned and a gala event planned but, COVID-19 and its restrictions prevented that from happening.

Instead the awards were presented with a combination of digital presentations and a bit of a roadshow around the various recipients, complete with the VW Amarok and beverages from Soho Wines and Quartz Reef. The upshot of that being that we have some fabulous videos on our website of the winners for your entertainment.

The Awards included the Sir Patrick and Justine, Lady Hogan Breeder of the Year, the Eight Carat Broodmare of the Year sponsored by Arion Pedigrees and the three Champion stallion trophies being the Dewar (Australasian earnings), Centaine (Worldwide earnings) and Grosvenor (New Zealand earnings) Awards, which were previously presented at the New Zealand Thoroughbred Racing Horse of the Year Awards dinner.

As they were also going to incorporate the successful group one awards dinner previously held by the Waikato branch of the NZTBA they also included their traditional awards, being the award for the breeder of the Seton Otway trophy for the Horse of The Year, the Mary Lynne Ryan Young Achiever, and the Personality of the Year award, along with trophies for the breeders of 21 Group One winners.

In the beginning of September to mark the start of the breeding season, the NZTBA President John Thompson started the ball rolling by presenting Waikato Stud and Garry Chittick with the new perennial trophy, kindly

donated by Joan Egan, for the prestigious Sir Patrick and Justine, Lady Hogan Breeder of the Year award.

In a very successful year for New Zealand breeders, the voting went right down to the wire with Waikato Stud prevailing from a stellar pool of finalists which featured Gerry Harvey, Nearco Stud, The Oaks Stud and Trelawney Stud.

According to NZTBA President John Thompson, the competition for the New Zealand Breeder of the Year Award gets stronger every year.

"The calibre of the candidates and the horses they breed is outstanding and it's always a very tough decision," Thompson said.

"The criteria are based on achievements that clearly reflect true breeding merit locally and internationally in the season under review. And when measuring that performance, we take into account the location and scope of the breeding operation and the success achieved in relation to that size.

"Our breeding is showcased by the likes of the Group One winners Probabeel, Miami Bound, Melody Belle and Avantage, just to name a few. There is a tremendous amount of investment in the New Zealand breeding industry and we are certainly seeing the results of that in the finalists for this award."

Group One winners bred at the respected Matamata nursery included Probabeel (Savabeel - Far Fetched) and Tiptronic (O'Reilly - Tiptoes), with Probabeel winning the Gr.1 Surround Stakes (1400m) in Sydney and the Karaka Million 3YO (1600m), while Tiptronic won the Gr.1 Herbie Dyke Stakes (2000m) at Te Rapa. Probabeel was also placed in the Gr.1 Vinery Stakes (2000m) and Gr.2 Phar Lap Stakes (1500m).

Once again, all three stallion Awards the Dewar, Centaine and Grosvenor also went to Waikato Stud, with Ocean Park taking out the Dewar ahead of Savabeel who claimed the other two.

The following week, at a small gathering at Haunui Farm in Auckland Marie Leicester was presented with the Arion Pedigrees Eight Carat Broodmare of the Year Award for her Iffraaj(GB) mare Meleka Belle. She is the dam of the fabulous multiple group one winning mare Melody Belle and Exaltation a winner of two races from three starts.

Melody Belle's (Commands [AUS]) achievements on the racetrack last season included three Group One victories in the history making Hawkes Bay Triple Crown, before a win in the Gr.1 VRC Empire Rose Stakes (1600m) and a second to Magic Wand in the Gr.1 McKinnon Stakes (2000m).

In the Autumn she was third in the Gr.1 Futurity Stakes (1400m) and the rich All Star Mile (1600m), before finishing fourth in the Gr.1 Doncaster Handicap (1600m).

These deeds also earned Melody Belle the Seton Otway trophy for the Horse of The Year which was presented to Leicester as her breeder. This award has been sponsored by Cathay Pacific for over 20 years.

Presentations have also been made of the two other awards traditionally presented at the Waikato Branch Group One annual dinner, the Personality of the Year Award won by Rick Williams and the Mary Lynne Ryan Young Achiever Award won by Julian Corban.

A passion for pedigrees has seen Rick Williams involved in the thoroughbred industry for well over 35 years, as a consultant, owner, administrator, NZTBA Councillor and for the last 20 years General Manager of The Oaks Stud.

In that time, at The Oaks he has overseen the development of some exceptional racehorses and excellent stallions, including the former Champion 2YO Darci Brahma who as a sire has enjoyed a very successful season in 2019/20. The Oaks owned Catalyst by that sire featured as a leading three-year-old during the year winning the Gr.NZ2000 Guineas, in fact it was a Darci Brahma quinella with Harlech running second. Catalyst went on to feature in what many say was the race of the year in Australasia, the C.S Hayes Stakes with Alligator Blood, and claim the New Zealand Three-year-old of the Year title.

Julian Corban has spent his lifetime at Cambridge Stud where his father Marcus was General Manager. He spent his school holidays working with the staff on the stud and at the age of 17 he joined the permanent staff under the guidance of Sir Patrick Hogan, where he started
