I agree to the following Terms and Conditions for the 2021 STALLION SERVICE SCHEME

- 1. A purchase shall be deemed to be made when the offer is accepted, or a deal successfully negotiated, and the mare cleared by the Stud;
- 2. The purchase price is exclusive of GST and GST shall be payable on successful purchases;
- 3. Payment in full is to be received by 20 March 2022
- 4. Interest of 6% per annum will be charged on a daily basis on all accounts not paid by 20th of March 2022;
- 5. I understand that the service is for the 2021 Season only and that a LIVE FOAL GUARANTEE will be given on mares certified in foal:
- 6. I understand that a live foal is one who Stands, Suckles and is insurable at 24 hours;
- 7. Live Foal Guarantee:
 - a) This L.F.G. will only apply if all charges are paid as at Tuesday, 20th March 2022;
 - b) Should a Live Foal as described in Clause 6 not eventuate the Club reserves the right to give a free return or a refund of the money paid per Clause 3, provided the mare is foaled at a stud or an approved agistment property;
 - c) The right to a L.F.G. is lost if the mare is sold or exported; and
